

The total number of sections taken together for classes XI and XII should not be more than 1/3 of optimum number of section allowed on the basis of land holding for any school.

The number of sections and students shall be restricted as per the actual facilities in the school.

For class rooms of size less than 500 sq feet the enrolment shall be 0.08 X size of class rooms in sq feet

Important Notes: 1.The total number of sections shall be restricted to 21 (as per prescribed dimension) according to the number of rooms reported by the inspection committee and further increase shall be subjected to specific approval of the Board on the basis of the request of the School as per affiliation byelaws.

- 2. The Computer lab may be shifted to a bigger room according to the dimension prescribed by the Board and submit compliance on the SARAS portal within 3 months.
- 3. The school is required to improve the facility of potable water and submit compliance on the SARAS portal within 3 months.
- 4. The school is required to dispose the live specimens available in the biology lab as advised by the Review Committee and submit compliance on the SARAS portal within 3 months
- 5. The school is required to arrange the books in the Library and catalogue them to make it organised and submit compliance on the SARAS portal within 3 months
- 6. The playground needs to be developed and improve outdoor sports facilities and submit compliance on the SARAS portal within 3 months
- 7. The school is required to follow the SOP laid down for labs and libraryand submit compliance on the SARAS portal within 3 months.
- 8. The school is required to renew all the mandatory certificates from time to time and directed not to remove videography link in future.
